When reflecting back at the past ten years—from the financial crisis of 2008 to now, we've experienced an unprecedented interest rate cycle and regulatory reforms that have reshaped the economic and banking landscapes. As the current Chair of the Maine Bankers Association, I've traveled around the state in the past year visiting

member bank presidents and CEOs and my assessment is positive. The industry has worked hard to overcome a decade of incredible challenges while focusing on growing our organizations. When Maine banks thrive, our **customers, employees** and **communities** prosper as well.

Strong Financial Performance

Here at Norway Savings Bank, 2018 was a record year of financial performance and we attribute our success to our great team of employees and our loyal customers. At the core of banking is relationship-building with businesses, neighbors and nonprofits. We never lose sight of our mission of delivering the best banking experience in Maine and we will continue to work hard to bring more good things—and color—to the communities we serve.

With record earnings in 2018 of \$13.9 million—an increase of 20.3% over 2017—Norway Savings Bank continues to be one of the strongest community banks in Maine. Our capital ratio is solid and we received the Bauer Financial 5-Star rating—a distinction we've earned for 29 years in a row.

Much of Norway's success is tied to our considerable growth in lending. In 2018, residential loans to families and individuals grew 5.89% and business loans were up over 5%. Consumer loan balances also grew, reflecting strong activity in marine and recreational vehicle financing. It's this lending that drives the Maine economy—and for that reason, we are especially proud of these numbers.

In today's modern world, consumers have many choices when it comes to finding a home for their deposits. To compete, we rely heavily on our incredible branch staff members, whose service, diligence and knowledge continue to drive positive deposit growth for the bank. In fact, our deposits grew 4.64% in 2018.

Norway's Asset Management Group continues to add clients and assets under management with sound, sage advice, proactive service and a can-do attitude that drives positive investment results.

Enhanced Customer Experience

With consumer expectations continuing to grow and evolve, particularly in the field of electronic services, Norway is poised to deliver. Our new Digital Delivery Team, comprised of employees from throughout the bank, strategically assesses customer technology and makes recommendations on improvements and upgrades. One of the primary technology standards we set for ourselves is to deliver in a "mobile-first/ mobile-only" fashion. This simply recognizes that most people use their mobile device exclusively (vs. a personal computer) to do their banking.

If you are a Mobile Solutions user, you have probably noticed the impactful upgrades we made over the last year – from adding easy, on-device enrollment and allowing you to add a Bill Payee to eliminating the Popmoney fee. We've made it easier than ever to move money, make payments and manage accounts.

In 2018, we introduced the NSB Cards App, which integrates into our Mobile Solutions App, enabling consumers to monitor and manage their debit card. You can even use the App to turn your card off if you suspect fraud. Because security is top of mind for most of our customers, we've seen unprecedented growth in adoption since its launch in September.

And now, applying for a mortgage has never been more convenient! In October 2018, we introduced a mobile-friendly site for consumers to complete a mortgage application. We're sure you'll appreciate the new streamlined mobile interface and easy-to-use workflow. To find out more, visit the Mortgage page at norwaysavings.bank.

The in-branch experience has also received an upgrade. If you frequent branches, you'll have noticed that our new transaction software system makes your trip much more efficient. In addition, the Topsham branch received a fantastic facelift and is now poised to deliver a more customer-focused and service-driven experience.

At Norway Savings, our employees take special pride in their wellness. We continue to offer employees one-on-one coaching with a dedicated health coach, and we've seen health costs stabilize and, more importantly, overall health metrics improve. Many NSB employees have not only changed their lifestyles and habits but have encouraged their family members to make better choices as well. And this past year, we've made it even easier to stay active! By waiving the fees to use our in-house gyms, we hope that more employees will use them more often.

We also recognize that part of wellness is financial fitness. That's why, in May, we held an all-day wellness fair dedicated to providing tips on financial planning, creating budgets and reducing debt. I'm particularly proud of these accomplishments and the bank will continue to invest in these important initiatives.


